Delegate must sell five(5) tickets to the 2010 Mrs. Kansas pageant. Each ticket is \$35 and includes the official Program book (a \$10 value)

AREAS OF COMPETITION:

- *Personality and Communication skills = 50%
 - A panel of judges will critique each delegate's ability to communicate, her personality, her self-expression, her achievements and her beauty.
- *Fitness and Health = 25%
 - Delegates will compete in a solid red, one or two piece swimsuit of their own choice.
- *Poise in Evening Gown = 25%
 - Delegates will be judged in an evening gown of their own choice.
